The Trustees have completed the audit report for the period 1 July 2024 to 30 June 2025.

This audit report will be published on the Trust Website and notification of the completed audit report published in the Mosman Daily 11th December edition As can be seen from this report more money is being paid out than is being generated from current investments.

On the basis of the expenditure pattern noticed during the Audit, the Trustees are also completing a review of the best ways for the Trust to support beneficiaries while also ensuring the longevity of the programme, As a result, it is envisaged there may be changes to amounts payable, or for what services are claimable, in Category A (Medical) and Category D (Utilities). This is to ensure future generations of Trustees can be supported. Any amendments to the Welfare Programme, Welfare Category Limits or Terms and Conditions, will be communicated to Beneficiaries and published on the Trust Website well before the end of the 2024/2025 financial year.

As previously advised all three of the current Trustees have full time roles, but are working to ensure the majority of claims are processed and paid in the second week of September, December, March and June.

Welfare Assistance Programme claims paid during the period totalled \$223,231.25
